Dr. Ben Danielson: A Champion of Health Equity and Civic Courage in Washington State

Civic courage is the willingness to take bold, principled action in the face of adversity, often at great personal or professional risk, to promote justice and improve society. One remarkable example of civic courage in Washington State is Dr. Ben Danielson, a pediatrician and former medical director of the Odessa Brown Children's Clinic in Seattle, Washington. His unwavering commitment to health equity and his decision to resign in protest against systemic racism within the healthcare system exemplify civic courage. His actions have sparked a critical conversation about racial disparities in medicine and inspired change within Washington's healthcare community. "We cannot allow injustice to persist simply because it has always been there," Dr. Danielson stated. "We have to push back, even when the cost is high, because that is the only way to create a better future" (Balk, 2020). Dr. Danielson's resignation in 2020 was not just a personal decision but a public stand against institutional racism within Seattle Children's Hospital, which oversees the Odessa Brown Clinic. By speaking out, Dr. Danielson not only risked his career but also exposed deeply ingrained systemic inequities, reinforcing the urgent need for healthcare reform (Salyer, 2021). heartbreaking to see the injustices that persist and the harm that they cause" (Balk, 2020). Furthermore, he has appeared at town halls, medical panels, and public forums to educate both

medical professionals and the general public about the pervasive issues of racism in healthcare and the need for policy-driven solutions.

His influence extends beyond the immediate effects of his resignation. He has continued his advocacy through public speaking, community engagement, and mentorship, inspiring future healthcare professionals to prioritize equity and inclusion. Danielson emphasized, "We must continue pushing for a system where every child receives the care they deserve, without bias or discrimination" (Salyer, 2021). His leadership has contributed to systemic changes in how medical institutions approach diversity and inclusion, making healthcare more accessible and responsive to the needs of underserved populations (Kelety, 2021). One concrete example of this impact is his role in advocating for implicit bias training in Washington's medical schools and hospitals. By working with policymakers and healthcare leaders, he has helped implement mandatory training programs that educate providers about racial biases and equip them with strategies to ensure fair treatment of all patients. His efforts have also contributed to the expansion of funding for clinics that prioritize culturally competent care, ensuring that more BIPOC families receive the medical attention they deserve without fear of discrimination. He has become a role model for young professionals who aspire to serve their communities with integrity and justice. By demonstrating that taking a stand against injustice is not just necessary but possible, he has encouraged other medical professionals to speak out against inequities and actively work toward a more just healthcare system.

Yet, despite these risks, Dr. Danielson chose to speak out because remaining silent would have meant being complicit in a system that continues to harm marginalized communities (Salyer, 2021). He poignantly noted, "If I didn't speak up, I wouldn't be able to look my patients in the eyes and tell them that I truly cared about their future" (Kelety, 2021).
